1. Minutes of April 25, 2021 Board Meeting:

Andrea Kahn moved and Beth Kalish seconded the motion to approve the minutes with some corrections. The Board unanimously passed the motion.

2. Treasurer's Report.

3. President's report

Congratulations were extended to Paula Ellman and Randi Wirth for their election to IPA Board. Letters will be sent to other North American Representatives on the new IPA Board when they take office.

'Psychoanalysis Today' meeting was held and there are no changes to NAPsaC nor APsaA fees this year.

We await NYLPI updates to our Bylaws.

Our insurance policy is paid for the year.

There was discussion about access to and use of NAPsaC Logo. It was decided that Board members would have access and be encouraged to use this, for example, when sending on NAPsaC business to their organizations.

Action: Secretary to forward logo to all Board members.

4. Constant Contact:

There was much discussion by the Board on both the use of Constant Contact and use of NAPsaC website Calendar. The original purpose of the calendar was for an exchange of information. Board meetings, as well as events of our organizations and other world organizations could be posted, making easy access to all members. Constant Contact was thought of as a directory so that flyers etc. could be sent out to members.

Discussion led to a deferred decision, awaiting further thought by ExCom.

Action: ExCom to discuss need and role of Constant contact

5. Relationship between NAPsaC and the IPA.

The Board agreed that it was important to encourage communication between the IPA board and NAPsaC. Communication with the North American Reps as well as the Reps from Europe and South America will be facilitated by the President and by the two NAm Reps who will be on the IPA Board.

6. Suggestions for topics for a Forum with NAPsaC Members and North AM Representatives as well as the IPA Executive.

There will be further discussion by the Board after the NAM Reps have had a chance to know each other and become familiar with the work of the IPA.

7. NAPsaC relationship with EPF and FEPAL

Our President as well as our Secretary will attend the upcoming IPA Congress and liaise with EPF and FEPAL. The President plans to attend the next EPF meeting in 2022 which will be held on Palm Sunday weekend.

8. Program Committee Update

Randi Wirth reported on the upcoming Tri-Regional event on July 31 at the IPA Congress.

NAPsaC Clinical Roundtable will be held virtually Saturday October 23 2021. The title is" Body to Body: The Impact of External Reality on the Analytic Couple". There will be panel representatives from NAPsaC FEPAL and EPF.

Dr Jaehak Yu reported that KPSG functions are progressing smoothly. The organization will be making an application for full Society standing to IPA this year for approval. The Board roundly congratulated him.
