- C. Mothering Alone Triregional Conference: reviewed. Meeting was very successful with cultural slant impactful. Video of this will shortly be available for purchase on NAPsaC Website for a minimal cost.
- D. Treasurer Report Sandra Borden: AS of today: 19,867.55\$ in account. Mothering Alone conference added 1160.76\$, but costs of running it: 1746.09\$, plus technical support: 911.25\$. Travel expenses have increased this year. Insurance payment also up by 100.\$ to 1466.\$ Website maintenance has gone up and is over budget to 1316.25\$ (was budgeted for 800).
- E. Sue Kolod showed a Power Point Presentation she had prepared to give to the APsA Board on What is NAPsaC. Lively discussion ensued. APsA and CPS do not show the line item of cost to individual members for NAPsaC making it invisible to members.
- F. A vote was held showing Board Members in favour ( ) of raising NAPsaC dues from 6\$ annually to 25\$. Board members were asked to bring this information to their Boards to discuss/vote on.
