 Minutes of 3/6/22 Board Meeting were reviewed. Andrea Kahn moved we pass the minutes, with Leigh Tobias seconding. The minutes were passed unanimously.

### 2. President's Report:

Several Board members attended and found the EPF Conference on Time honouring Jorge Canestri very valuable. This led to a discussion of the viability of meeting people and colleagues at future conferences in person. AS the force of the pandemic varies so much by region, this is still uncertain. There will be a joint presentation (PCC,CIPS, NAPsaC) on June 11 on Psychological Reparations. IPA Conference in Vienna in July 2022 will be in person and focus on the Ideal and the influences of social/environmental/cultural factors. FEPAL biannual meeting in September will be virtual. June 2022 APsaA conference is in person. ACTION: Mary Kay O'Neil will be attending APsaA conference on behalf of NAPsaC.

Psychoanalysis Today journal paper edition is slated to be shut down, with a final farewell edition with "Greatest Hits." The Psychoanalysis Today e-journal is still available on the IPA website with back issues also available. New editions will be forthcoming.

3. President gave a report of NAPsaC's activities to CPS.

Hearty congratulations were given to DR Jaehak Yu and the Korean Study Group members who are now an IPA Society. They voted to remain part of the North American Region even after the IPA forms a fourth Asian-Pacific Region. Dr Jaehak Yu was welcomed now as a voting member.

## 4. Treasurer's Report:

As of today, the balance in our bank account is \$17,066.52. A few large bills have already been paid this year and include the E-Journal, D&O insurance and our donation to Ukraine. Taxes are being filed with our accountant and will meet the May 15th deadline. We do not expect to owe any taxes this year. Due to a lack of travel expenses over the past two years, our bank balance is healthier than in past years.
