1. Minutes of September 26 2021, and November 28, 2021 Board Meeting: Minutes were reviewed and approved.

### 2. President's Report:

The IPSO North American Vice President Gerard Sobnosky was introduced and welcomed to the meeting as guest.

The annual in person NAPsaC Board meeting cannot be held due to Covid. Instead a virtual meeting will be held on MARCH 6 2022. FEPAL,EPF Presidents and VP's as well as IPA President and Executive colleagues have been invited and have accepted.

Since we are meeting internationally, there are different time zone start times which are listed at the end of the minutes.

3. Treasurer's Report: Currently we have 22,889.05\$ in our account. The annual budget will be presented at the March Board meeting. The Body to Body event organized by the Program Committee was a first paid event .

**Action:** Treasurer to investigate using a pay platform for future events.

#### 4. Secretary's Report:

The reported leaks in an old program" Find an Analyst" have now been fixed.

Discussion ensued about having a Recording(non-voting) secretary to provide minutes for the Board Meetings. Suggestions were made that this could be an attractive position for an Analyst in Training to be mentored and gain experience in administrative work and the function of NAPsaC.

Action: Gerard Sobnosky offered to take this back to IPSO for discussion.

5. President Elect's report: Lawyers re Bylaw update. Nothing yet to report.

### 6. Psychoanalysis Today(PT).

President reported she attended a meeting about the future of this e-journal. As of now, the E-Journal has been ended. Bill Glover added to the President's report that an ad hoc committee is being drawn up including IPA representatives and PT Board members to discuss the future of this valuable initiative. PT has served as a unique voice for psychoanalysis by representing international voices as well as its translation into 5 languages. Financial issues as well as governance have arisen, such as the location of incorporation in Uruguay. One more issue will be coming out in 2022.

**Action:** Treasurer to follow up with Paul Crake re: our financial commitment to PT for the upcoming year.

7. Holmes Commission Update. Bill Glover reported an overwhelming support by psychoanalysts in volunteering to be interviewed by the Holmes Commission for their research. A report should be ready by mid 2022.

8. Intra-Regional Collaboration Committee: The need for a nominating committee for a website chair was discussed.

**Action:** Secretary to discuss with Totera their training our admin to provide Constant Contact support. The ExCom will discuss at their next meeting the forming of a nominating committee to search for a Website Chair.

9. Culture Sharing: This month Julie Hendrikson, NPSI's Alternate Board member, summarized her Society's history, culture and representation to the Board.

**Action**: As decided at our last Board Meeting, presentations will begin with the other Societies of CIPS, then the CPS, APsaA and the Non-Voting Members. The next presentation will be at the April Board meeting.

10. Program Committee: Randi Wirth reported that the Tri-Regional Committee is in the process of planning a panel on Terrorism and Radicalization. More information to follow.

**Action**: ExCom to discuss a "Town Hall" format event sponsored by NAPsaC inviting all North American Representatives to this forum with members of IPA potentially in April 2022.

11. IPSO and NAPsaC: Discussion ensued between NAPsaC Board members and Gerard Sobnosky to involve IPSO members. Both organizations are fully in support of collaboration.

**Action**: Gerard to discuss with IPSO members a paper prize sponsored by IPSO and NAPsaC for Analysts-in-Training. Gerard to be included in next Board meeting.

12. Other Business. Dr. Jaehak Yu reported that Korean Psychoanalytic Study Group's initiative to become a full society has been delayed. The Korean group has split legally and financially into two groups. His is the KPSG; the other is KAPA. KPSG has now been moved to a provisional society, by their inclusion of non-MD's, and therefore now in accordance with IPA guidelines. The other group is upholding MD's only, against IPA recommendations, and remains outside of IPA guidelines. This was a difficult developmental step for the Korean Study Group to have to take.
